### Objectives

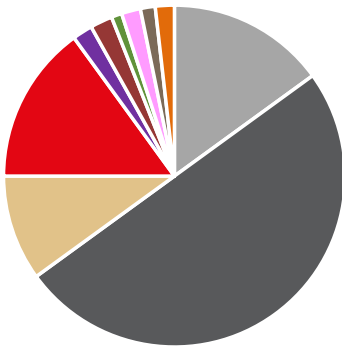
