### Objectives

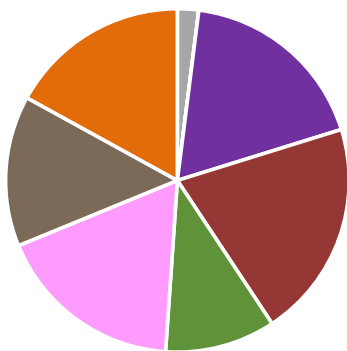
